to put up \$50,000 of his personal funds to help secure the loan from PNC Bank.

Gullette voted in favor of the UBT providing the \$75,000 guarantee.

Tony Haygood, Mayor Pro Tem and UBT member, stated that the information for the urgent care center in his opinion wasn't presented clearly.

'We were given the information and then it was withdrawn — and then presented to us again for our support. It was never explained in a way that would make me comfortable to make a decision on it," said Haygood, who cast the only dissenting vote when the UBT agreed to help guarantee the loan.

Ala Whitehead and Chris Lee, like Havgood, are members of both the Council and UBT. Whitehead voted in favor of committing to the \$75,000 guarantee when the UBT voted. Lee was absent at that UBT meeting and was not in attendance at the April 28 Council meeting when the matter was discussed.

Dr. June Samuel, director of student health services at Tuskegee University and a member of the Tuskegee Medical Clinic Board, also stood in favor of the Urgent Care Center. She stated that the University and the City have been talking for several years about getting urgent care in the community for the students.

"We need to reassure to the parents" that progress is being made and we are working to get the center in the community," Samuel commented.

Several Tuskegee University students were in the audience, including a young lady who gave a personal example how important it is for the City to get an urgent care facility to the community.

After the citizens' comments, Care Ambulance gave a presentation about the service calls they receive in the community and asked for support from the city for an additional ambulance to be housed in the community.

Care Ambulance service is willing to provide the additional ambulance, but wants the city to sign a contract with them to be able to provide additional ambulance service. Care does not have a contract with the city or with the county.

Other business during the meeting:

• The city passed a resolution to purchase the Trader Property on the Downtown Square in Tuskegee at the market value of \$11,000 to make improvements to the vacant building.

•A resolution was passed for the resurfacing project on Old Montgomery Road from Payton Drive to Franklin Road.

 The city will change personnel policies to allow employees to have electronic time entry, instead of using a punch-in time clock.

• The city will open an operating account at Liberty Bank, which be where the additional 2-cent sales tax (of the city's 10-cent sales tax) will be deposited. Liberty Bank is the former First Tuskegee Bank.

•A resolution was passed giving the City Manager Harvey Smith authority to apply for a Transportation Alternative Program grant. The grant will allow the city to build a sidewalk from Webb Street to Booker T. Washington High School. It is a safe route grant.

• The Public Works Department was commended for cleaning up the city and a resolution was passed to officially welcome Michelle Obama, First Lady of the United States to the community. She will speak at the May 9 Tuskegee University commencement.

•Head Start has a new website that was presented to the council. The site has ways to enroll a child into Head Start, the different services Head Start has to offer, mandatory information such as Financial Reports and a way to make donation, either by volunteering time or making a monetary donation. The site was launched at the beginning of May.

Marsh circulated to senators last week, will be the spear point of the first major push for gambling legislation in the Legislature in over five years, according to published reports.

Minutes after Marsh's press conference concluded, the Alabama House Republican Caucus endorsed a budget plan that included a gaming compact with the Poarch Band, who have offered to give the state \$250 million to address next year's budget woes.

Marsh said at the press conference he did not know what the ultimate growth numbers would be, but suggested that the gambling plan could give the budget breathing room.

"It should take us many years in the future to get these other things under control," said Marsh, referring to growing costs.

Bentley sharply attacked Marsh's proposal in a speech to the Montgomery Area Chamber of Commerce on Monday, calling it "the worst piece of legislation I have ever seen.'

"To think we have to depend on some of the most dependent people in our population to fund our government when corporations won't even pay their share — we're better than that," he said.

"The governor seems to think this is an ugly piece of legislation," Marsh said. "I think it's a pretty good choice

for people to make. What I've seen is a pretty ugly tax package."

The governor has threatened to veto the General Fund budget and bring the Legislature back into special session if the budget does not include his revenue package.

The legislation authorizes the governor to enter into a compact with the Poarch Band of Creek Indians, who operate casinos in Atmore, Montgomery and Wetumpka.

The tribe has offered the state \$250 million to address this year's General Fund woes in exchange for a monopoly on gaming operations. Marsh has said that Republican senators do not want to grant a monopoly to any entity.

Non-exclusivity would significantly lower the amount of revenue the state would gain from an Indian tribal compact, but by taxing other entities at a higher rate, the state could potentially see more revenue from those locations.

Allowing slot machines and table games at any location in the state would allow the Poarch Band to have the machines, though the process could take time, depending on Bentley's willingness to negotiate a compact with the tribe. The governor said Monday he would not negotiate a compact before his revenue package was put in place.

were already looking for Cox on charges in both Tuskegee and Auburn when he was apprehended only hours after a reported burglary in Auburn, according to a statement from Patrick.

"Once Cox was developed as a suspect, our investigators called in the U.S. Marshals Task Force to assist in locating this suspect so we could get him off the streets as soon as possible, once we became aware of the crimes in Auburn, we all join forces and worked together. Cox is a suspect in at least two other crimes in Tuskegee and at least three that occurred in Auburn," Patrick stated.

The arrest was made by the U.S. Marshals Service Fugitive Tax Force after locating the suspect in Tuskegee only hours after a burglary

a.m. the morning of April 30.That burglary was in the 200 block of North Donahue Drive in Auburn, according to a report in the Opelika-Auburn News.

At approximately 9:46 a.m. Thursday, Cox was taken into custody. The 2007 Dodge Caliber reported stolen earlier in the day was recovered.

In an interview with WSFA television, Macon County Sheriff Andre' Brunson stated, the "dangerous" suspect was caught with the help of several local and federal agencies. The crimes occurred in areas of the city he's familiar with," the sheriff said.

He applauded the work of the agencies involved to get the alleged predator off the streets.

"We apprehended a subject that was wanted in four sexual assaults and four home invasions," Brunson said. "Anytime you have someone assaulting females, anytime you have someone breaking into homes, you want to get them caught as quickly as possible and we did that. I would like to thank the Macon County Sheriff's Department, the Auburn Police Department, the Tuskegee Police Department and I want to give a special thanks to the U.S. Marshal's Fugitive Task Force for a job well done.

Brunson pointed out that the Sheriff Department's involvement in the case is because two of the department's deputies are assigned to aid the U.S. Marshals Service Fugitive Task Force.
